The America 250 Foundation, Inc. ("Foundation") submitted its Form 1023, Application for Recognition of Exemption from Federal Income Tax on April 9, 2020. ("Form 1023"). Leading up to date that the Foundation filed its Form 1023, it was reviewing the types of organizations that it may seek to qualify under Section 509(a)(3). This was due, in part, to the complex nature of the entities governed under Section 509(a)(3) of the Internal Revenue Code, and also, due to ongoing discussions with the U.S. Semiquincentennial Commission to determine if any supporting relationship would exist between the entities, and in particular, the support provided by the Foundation to the Commission. Notably the Foundation did not have any expenditures or revenue at any time from the date of its incorporation (June 4, 2019), through the end of its fiscal year (September 30, 2019). Accordingly, the Foundation did not believe that it would be required to file a Form 990 for its first, short-year tax period for several reasons, which we have summarized in the following request for abatement of any late filing penalties that the Internal Revenue Service may elect to assess against the Foundation.

1) The decision to mirror the fiscal year (ending September 30) of the Federal entity (the U.S. Semiquincentennial Commission) was not made until the Foundation filed IRS Form 1023 on April 9, 2020, applying for nonprofit status - long after the filing deadline of February 15, 2019 (the 15th day of the 5th month after FY2019 ended for the Foundation).

2) Although the Foundation filed its Articles of Incorporation on June 4, 2019, the Board of Directors of the Foundation did not even approve its Bylaws until December 17, 2019.

3) There were no expenditures or revenues for the Foundation for the four months from June 4, 2019 until the fiscal year ending on September 30, 2019.

4) Revenues and expenditures began on November 1, 2019, when the Foundation opened its bank account. Before that time, under Public Law 114-196, the Administrative Secretariat was managing the Federal expenditures of the U.S. Semiquincentennial Commission. It was after the National Park Service granted permission for the Administrative Secretariat to create the Foundation, that the Foundation got its EIN, and also filed its Articles of Incorporation (These entire factors were detailed in the supplemental material which accompanied the successful filing of the IRS Form 1023 application)

5) The Foundation completely is aware of its obligations, specifically the FY 2020 filing deadline of February 15, 2021 (by the 15th day of the 5th month - after our fiscal year ends on September 30, 2020). And this filing will take place in a timely manner after our annual audit, This FY 2020 filing will be on IRS Form 990, and not this 990 EZ form.

6) The Foundation, which received its IRS determination letter of July 16, 2020 recognizing it as a 501(c)(3) nonprofit entity as well as a Type II supporting organization under IRS Section 509(a)(3), is now filing its 990EZ form to remain in compliance with the annual filing requirements,
