STATEMENT FROM THE CHAIR

January 31, 2025

I am pleased to provide this progress report for 2024 on behalf of the U.S. Semiquincentennial Commission (the "Commission") and its supporting organization, America250.org, Inc. (the "A250" and together, "America250"). This is the third such report since my presidential appointment as Chair of the Commission in July 2022. We have made considerable progress toward the Commission's goals since my appointment, and I am excited to share our successes from 2024 with you.

In the report that follows, you will see how America250 is building momentum as we approach July 4, 2026–engaging communities from sea to shining sea, fostering partnerships with key stakeholders, and laying the groundwork for the largest and most inspiring commemoration in our nation's history. We have been making space for all Americans–at the local, state, and national level–to join the movement, and we are excited to work with the Trump Administration to create the big moments that will define America's 250th.

We have been coordinating closely with the Trump Administration and are delighted by their deep commitment and vision for this important milestone, as well as President Trump's personal dedication to make America's 250th a historic success. In addition to the memo we sent to President Trump last November, along with a separate letter to First Lady Trump, we have also engaged members of the Trump Administration to help us guide the conversations necessary to properly brief our internal and external stakeholders. Our West Wing contacts have been very helpful in relaying their shared interests in a collective planning effort worthy of the American public and have been very supportive of our work to date. The White House issued the Executive Order entitled, "Celebrating America's 250th Birthday" establishing Task Force 250, and we could not be more pleased. You will see that the White House specifically identified the U.S. Semiquincentennial Commission and their intent to coordinate the federal agencies' communications and will continue to request our recommendations and advice.

America250's work will continue as the national, nonpartisan organization charged by Congress to lead the 250th anniversary with the backing of all three branches of the federal government and its independent agencies. We look forward to working collaboratively with the White House, federal agencies, and our partners across the country to ensure that this milestone is not just a success but will also provide a sustained global platform in tandem with the World Cup in 2026 and the LA Olympics in 2028. We need and welcome the active participation of leaders at all levels: local,

state, federal and international. We intend to reach 350 million Americans ("350 for 250") for this historic milestone, and the White House Task Force 250 will be a critical partner in this effort.

None of our progress would be possible without the continued support of Congress. On behalf of the Commission, I extend my deepest gratitude to everyone who has taken time to meet with us, attend our receptions and events, and support our work to date. I am especially thankful for the engagement and leadership of our Congressional Commissioners, Senate, and House Majority and Minority Leaders, and many current and potential members of the Congressional America250 Caucus and their dedicated staff. Like you, we remain committed to faithfully serving the American public - working for the people, as Congress intended, and to the benefit of this great nation.

I look forward to continuing to work closely with the Commission to fulfill our critical mission to the American people here and abroad.

I. Executive Summary

This past year was filled with achievement, collaboration, huge advancements, and meaningful connections for America250. From launching innovative public initiatives to forging strategic partnerships, we made significant strides in engaging Americans across the nation in celebrating and commemorating the upcoming 250th anniversary of the United States. Among the highlights from this past year:

- Nationwide Representation: We now have 56 official State and Territory and Washington DC America250 Commissions, ensuring this celebration will touch the lives and reflect the experiences of all Americans. This is no small feat considering that each Commission was formed by either state legislation, administrative action, or an Executive Order by the Governor.
- Largest Bipartisan, Bicameral Congressional Caucus: In December, the America 250 Congressional Caucus became the largest bipartisan, bicameral caucus in Congress. Incredibly, the caucus reflects near-equal representation from both parties—a rare and powerful testament to our unifying mission—and exceeded our initial goal of 250 members.
- Honorary National Co-Chairs Announced: This summer, President & Mrs. Bush and President & Mrs. Obama personally agreed to serve as Honorary National Co-Chairs of America 250.
- Landmark Corporate Commitments: We were thrilled to secure a \$15 million commitment in December from our largest partner to date (to be announced shortly), which will be instrumental to ensure America's 250th anniversary is truly an unforgettable celebration and a public-private partnership. Also, in May, Walmart was announced as a founding sponsor, supporting America250's national service initiatives.
- Strategic Partnerships: We announced a number of new National Resource Partners with groups, including the National Congress of American Indians (NCAI), Points of Light, Meridian International Center, National Women's History Museum, American Association of State and Local History (AASLH), iCivics, and More Perfect.
- America250 Ambassador's Circle: We launched a collection of prominent and respected individuals who will lend their public profile, cultural expertise, and community relationships to raise awareness of the Semiquincentennial. This group includes the following individuals: Ed Rendell, Former Governor of Pennsylvania; Senator Cory Gardner, Former U.S. Senator, Colorado; Doris Kearns Goodwin, Author and Historian, Boston, Massachusetts; Willie Brown, Former Mayor, San Francisco, California; Gloria Estefan, Singer, Miami, Florida; Lance Bass, Pop Icon, Laurel, Mississippi; Darla Moore, Businesswoman, Charleston, South Carolina; and Mary Smith, former President of the American Bar Association, Enrolled Member of Cherokee Nation, Chicago, Illinois.

- Public Engagements: Chair Rios participated in many high-profile public events and
 engagements to raise awareness of America250, including with the following institutions:
 The National Governors Association, the Milken Global Conference, the Points of Light
 Conference, the U.S. Conference of Mayors, the Fortune Most Powerful Women Summit,
 the Hispanic Leadership Summit, and the 250th anniversary of the Boston Tea Party,
 among many others.
- Judicial Branch Participation: As one of the few entities representing all three branches of government, we were honored that the Supreme Court hosted our Commission meeting on September 19. The previous evening, they also hosted a reception on our behalf at the Supreme Court with all members of our Congressional Caucus invited as well as other stakeholders including federal agencies, partners and sponsors and featuring Ken Burns, the documentary filmmaker, as our guest speaker.

National programming for 2026: In 2024, we announced our national programming, all of which was part of the Playbook approved unanimously by the commission in March. **To be clear, everything that we are planning is unprecedented in scope and scale.** These programs include:

- America's Invitation: A unique opportunity for Americans to share their stories and their hopes and dreams for the future of our country. Together, these stories create a portrait of America at 250 years. *Launched: Summer 2023*.
- America's Field Trip: A multi-year, national contest that invites students in grades 3-12 to submit artwork, videos, and essays, answering the question, "What Does America Mean to You?" for the chance to receive unique experiences at iconic American historical and cultural sites. Supported by America's Field Trip founding sponsor, BNY. *Launched: September 2024*
- Our American Story: A national effort to compile the largest oral and visual history and understanding of the United States, supported by America250 founding sponsor, Walmart. *Launched call for nominations July 2024*.
- America Gives: A multi-year, year-round effort focused primarily on volunteer service but will also include charitable giving and public service including military service. Through this effort, America250 will establish the largest year of volunteer hours ever recorded by the U.S. in 2026. Supported by America250 founding sponsor, Walmart, America Gives will create a legacy of service beyond 2026. *Previewed: September 2024*.
- America's Culture: An opportunity to showcase American art forms and cultural touchstones through music, dance, and other forms of creative expressions to showcase America's rich and deep shared connections.
- America Innovates: A traveling tech expo that will display America's greatest innovations and inspire the next generation of creators to visualize their own future through hands-on interactive experiences.
- America Waves: A unique way to create moments of connection for all Americans to come together with their communities at a designated local moment in time, wave their American flags, celebrate America's 250th, and honor the contributions of those who brought us to where we are today.

- **Time Capsule**: A collaboration involving all 50 states, five territories, and the District of Columbia to collect items for a time capsule to be buried in Independence Mall in Philadelphia on July 4, 2026.
- **July 4 Activations**: A historic national celebration in Washington, D.C. and beyond, with celebrations across the country on July 4, 2026, in which we will partner with established groups who host legacy July 4 events and parade organizers at the state and local levels.

America250 has leveraged extraordinary momentum due to a considerable amount of focused and strategic work behind the scenes. We have largely completed the "Fresh Start" reset described last year to place the American people at the center of this commemoration, with the planning and programming decisions determined by the Congressionally appointed Commissioners. Our ability to "Educate, Engage, and Unite" has guided our planning efforts. Our priority through all of this work, is to ensure America250 is a conscientious fiscal steward of both appropriated and private funding and that all decisions are made with this in mind. We honored our commitment to match federal appropriation in FY 2024 via private contributions with our newly committed \$15 million sponsorship and will continue to do so through these strategic partnerships. We will continue to make decisions to serve the American people, which will require America250 to be a nimble, lean, and execution-focused organization. We stand ready to provide the most inspiring celebration that is of the people, by the people, and for the people, of this great nation.

II. Background: Where we have been

The first three years of Commission activities focused on developing a strategic plan to guide the Commission's work through 2026. A comprehensive planning process was co-led by then-Commissioner Rosie Rios and Dr. Anthony Rucci, an independent Emeritus Professor from Ohio State University. The outcome was presented in the first Annual Report to the President in December 2019, which outlined the following strategic priorities:

- Create an inspirational vision for America250 among all Americans and each American;
- Build relationships and secure valuable partners and stakeholders;
- Be comprehensive in scope, and both national and local in impact; and
- Ensure excellence in the execution of America250 to provide effective, ethical, and transparent stewardship.

These priorities continue to guide the Commission's work today, with a particular emphasis on public engagement in the design process. During this same period, the National Park Service issued an RFP to select the American Battlefield Trust (ABT) as the legislatively mandated Administrative Secretariat in April 2018. In June 2019, working with the Commission, the ABT recommended the creation of the America250 Foundation, Inc. to facilitate and enable significant development and fundraising efforts. The Foundation is incorporated as a 501(c)(3) in Delaware and is a Type II sole supporting organization per 509(a)(3). Since May 2020, the Foundation, now known as the .Org, has effectively provided most of the administrative services that were originally being provided by ABT.

Throughout this stage, a strong focus was maintained on governance oversight through routine and regular convening of Commissioners at official quarterly meetings, as well as a robust Commission subcommittee structure which included: Executive, Finance, Development, Government Affairs, Programs & Planning, Marketing and Communications, and Governance Committees.

The period between 2020 and 2022 was primarily focused on developing frameworks and strategies for building out programs and soliciting partners, with periodic research to ensure that America250's planning aligned with the expectations of the American people. In July 2022, President Biden appointed Rosie Rios as Chair of the Commission. Chair Rios's mission was to put the American people first in the solicitation of ideas and inspiration, while continuing to align with the Commission's strategic objectives.

After extensive consultation with the Commission's Executive Committee, Chair Rios transitioned the organization to a new managed services model for the design and execution of programs and partnerships, allowing for immediate scope and scale without extensive hiring at the America250 staff level. This new model utilizes experienced outside professionals with extensive public engagement and media expertise under contract to execute strategic initiatives and allows for greater flexibility and cost management as opposed to the more fixed costs associated with staffing internally.

The goal was to produce a streamlined America250 Playbook that identifies a concentrated menu of priority programming interests including:

• What national programs will be designed and managed directly by the Commission;

- What programs at the Federal, State, and local levels can be elevated through co-branding with America 250; and
- What programs can be most impactful through collaborative partnerships.

Up until 2022, America250 has encountered a number of governance challenges, particularly in its early stages, including legal actions (which have been dismissed, and, at this time, neither the Commission nor the Board have any outstanding litigation). Significant strides have been made under Chair Rios's leadership to restore trust in America250 and refocus on its core mission. This includes engaging a series of independent, outside workplace and governance specialists who have delivered concrete recommendations on how to best mitigate any issues and work together moving forward to return both programming and governance as priorities of the Commissioners. In the past, America250.org, Inc., formerly known as the America250 Foundation, Inc., which was initially set up to focus on facilitating procurement and development, became the default governance of the Commission because of the initial Commission dysfunction that precluded attaining a quorum at the quarterly meetings. Since Chair Rios' first Commission meeting as Chair in September 2022, the Commission has achieved a quorum at every official Commission meeting.

To ensure transparency and fiscal responsibility, an independent accounting firm was retained to conduct a comprehensive Agreed Upon Procedures review of both the Commission and America250.org's financial records from 2019-2021. The intent of voluntarily engaging in this additional fiscal review was to put to rest lingering questions about fiscal management, exploited by previous commissioners and misrepresented in the media.

Despite these legacy challenges, under Chair Rios' leadership, America250 has succeeded in engaging with the American public and activating initial programming. In addition to launching America's Invitation, by the end of 2024, all 56 states and territories had established State-level Commissions, 23 Federal Agencies and 35 private entities had signed on as partners and 260 members of Congress had joined the Congressional America250 Caucus. Furthermore, multiple national surveys conducted by America250 among Americans since 2019 have consistently produced guidance that reflect a robust level of enthusiasm for America's 250th anniversary of independence.

The Commission is continuing to be good stewards of its appropriations. This year America 250 continued to decrease its fixed costs by moving its headquarters from Alexandria, Virginia to GSA space in the Ronald Reagan Building in Washington, DC. Reducing its footprint from 9,900 sq ft in Virginia to 2,883 sq ft in Washington, DC resulted in lower recurring rental costs by 57%. Further, America 250 continued a regular review of staffing, managed services firms and alignment between the Commission and America 250.org, Inc., with a staffing plan around the external resource model approved by the Commission's Executive Committee in December 2022 and December 2023. Current priorities center on organizing all staff as a single unit as visualized in a single organizational chart - truly One250 was completed in the second quarter of FY 2024. This realignment ensures that we are a lean, nimble organization equipped to meet the scale necessary to plan and execute a Semiquincentennial worthy of the American people. To that end, America 250 experienced a 33% decrease in fixed costs from FY 2023 to FY 2024, primarily due to a reduction in the number of permanent employees. Further, America 250 continues its commitment to Congress to ensure that almost 90% of the budget is dedicated to programming and public engagement. Continuous improvement, maximum efficiencies and fiscal stewardship remain a top priority moving forward.

III. Strategic Update: Where we are today

America 250 successfully launched its first public initiative on July 4, 2023, with America's Invitation. This was the first comprehensive public engagement campaign for the Semiguincentennial. At the heart of America's Invitation is a once-in-a-lifetime opportunity for Americans across the country to share their unique stories, hopes, and dreams about what being an American means to them and what they love about our nation through a video portal. America's Invitation is an ongoing campaign we will use to maintain a steady drumbeat of public engagement and to communicate directly with the American people about how they want to celebrate and commemorate this historic milestone. America's Invitation, asks the public to share their own American stories and reflect on what this country means to them and their hopes for the future through photos, videos, poems, essays, songs, and more. Our call-to-action was amplified across major broadcast and social media platforms in the days following July 4 — including from the stage of PBS's national broadcast of A Capitol Fourth, at-large-scale Independence Day events, including the Wawa Welcome America Festival in Philadelphia and George Washington's Estate at Mount Vernon in Virginia. America's Invitation was also highlighted by the Department of Veterans Affairs in a newsletter to 11 million veterans, military families, and other subscribers, on the National Park Service's social media platforms, reaching more than 5 million followers, and by the U.S. Department of Education, the Library of Congress, AmeriCorps, the U.S. Mint, and the U.S. Government Publishing Office, State Commissions, and others.

America's Field Trip

America's Field Trip is a nationwide contest from America250 that invites students in grades 3-12 to submit essays, poems, or art, reflecting on what America means to them for the chance to earn a once-in-a-lifetime field trip experience to one of our nation's most iconic historical and cultural sites. For both the pilot (2024) and current contest (2024–2025 school year), a total of 75 first-place awardees and their parents choose from more than a dozen specially-curated experiences across the country, receiving free travel and accommodations. The 75 second-place awardees receive a cash award, and the three teachers associated with the highest-scoring submission in each grade level category also receive a cash award.

The contest formally launched on March 4, 2024, as a three-month pilot program, with May 17, 2024, as the deadline for submissions. Kicking off America's Field Trip as a pilot contest gave us the ability to gather insights and refine components of the program in preparation for scaling the contest for 2025, 2026, and beyond. Among the primary goals for this pilot was building a foundation for youth-focused America250 programming and additional educational programs and partnerships geared toward engaging families and younger Americans.

For the pilot contest, we initiated an open call to America250 Ex Officio Commission members, including all National Park Service (NPS) and Smithsonian locations, to identify field trip destinations. The number of field trip offerings was limited to 11 to ensure each awardee would be able to go on a trip with at least one other student.

The BNY Foundation serves as a founding sponsor of America's Field Trip, having awarded America250 a three-year grant to support the execution of the contest. We also issued an RFP and retained a contest administrator to refine the official contest rules, design and implement the online submission portal, manage data collection, and ensure proper deletion of data after the contest ended. Probability Works screened all entries, notified contest winners, coordinated travel arrangements for awardees and parents, verified awardee eligibility, conducted background checks

for chaperone adults, and handled reporting and the issuance of tax forms.

Leading up to the launch of the pilot contest and throughout the submission period, America250 conducted extensive outreach to educators, parents, and school communities to spread the word and drive awareness of the contest. This included engaging more than 75 educational and education-adjacent organizations and hundreds of national, state, and local constituency groups. In partnership with worldwide ed-tech leader Discovery Education, America250 shared resources to help educators bring America's Field Trip to classrooms, including customized digital activities and lesson plans in English and Spanish. Chair Rios participated in multiple media interviews and America250 hosted a Facebook Live featuring representatives from Discovery Education and the panel of educators advising around the contest. We also deployed a paid media campaign that consisted of digital advertising on a variety of platforms and channels, working with micro-influencers, and sponsoring newsletters to share contest information with parents and educators on the platforms they were already using. Advertising reached millions of parents and teachers nationwide, but also cast a wide net of stakeholder interests around the country.

The pilot contest garnered thousands of submissions from students in 49 of 50 U.S. states and two U.S. territories. In June, a panel of current and former educators judged the entries and selected 150 students hailing from 44 U.S. states and territories as first- and second-place awardees. We worked with trusted educational stakeholders, including the National Council for the Social Studies, the National Council for History Education, and the America250 Civics, History, and America's Future Advisory Council to identify and recruit educators to serve as judges.

The public announcement of the inaugural cohort of winners on July 8 included a large-scale billboard activation in Times Square designed to celebrate the awardees and acknowledge their achievement. America250 also deployed run-of-site display ads on USAToday.com, driving to the awardee page of the website. These high-visibility activations served not only as a public recognition of the awardees, but were also a means to promote America's Field Trip in high-traffic spaces. We also coordinated with State and Territory commissions to acknowledge the awardees locally, created a dedicated page on the America250 website to highlight the winning submissions, and secured extensive media coverage.

The field trips for the 75 first-place awardees and their parents took place in July and August 2024. We received extremely positive feedback from students and parents who participated in the field trips—the mother of a Nevada awardee said, "When the country can feel divided, it's important to remember the beliefs we share. Through the trip, the kids who represent our next generation found common ground and met people from outside of their friend groups and neighborhoods. Now they have new friends from across the country!" A student awardee from Alabama shared, "This was a once-in-a-lifetime opportunity that I'd recommend for anyone who wants to learn more about our country. These field trips [don't] shy away from any part of our history, making it all the more authentic and enjoyable." We are pleased to share that we were able to launch a successful Pilot program and provide these once-in-a-lifetime opportunities for students and their families for under 1.6 million dollars.

Following the pilot contest, we also sourced feedback from awardees, stakeholders, and staff to identify areas of improvement that could be applied to the next iteration of America's Field Trip in the fall. From logistics to engagement strategies, we worked to incorporate this feedback and made minor program adjustments so that we are running an efficient and impactful contest for the 2024–2025 school year.

America 250 launched the second iteration of America's Field Trip, this time for the full school

year, on September 16, 2024, timed around Constitution Day and Citizenship Day. The contest will remain open for submissions until April 16, 2025, and includes several field trips from the pilot contest as well as several new experiences. We began soliciting proposals for 2025 field trip destinations in the spring of 2024 and received nearly 80 submissions, which we narrowed down to more than one dozen field trips for the first-place awardees.

Our outreach efforts to continue promoting the contest are ongoing. In December, Chair Rios participated in a satellite media tour that included more than two dozen radio and television interviews. More on what is ahead for America's Field Trip can be found in the next section of this report.

Our American Story

Our American Story is America250's national oral and visual history project to collect, share, and preserve stories from people across the United States of America ahead of the nation's 250th anniversary in 2026. This project builds on America's Invitation. Our American Story will gather stories from all 50 states, 5 territories and the District of Columbia in the year leading up to the Semiquincentennial. This project's widespread reach will allow America250 to organize the nation's most representative American story to date and provide a snapshot of our country to inspire future generations to celebrate the richness of our shared story.

The majority of work on Our American Story in 2024 was spent planning and refining the program so that implementation could begin in earnest in 2025 and fully launch on July 4 of this year.

• Story Nominations: Preliminary work has begun to build a "story bank" to help identify individuals and communities with engaged storytellers. On July 4, 2024, America250 announced a call to action for Americans to nominate unsung champions in their communities with a story to share. The nomination program is powered by founding partner Walmart. The nomination program included a video and online nomination form, which is being regularly amplified across America250's organic social media platforms and email programs.

On October 3, 2024, U.S. Customs and Border Patrol began running the video and a QR code to submit a nominee while waiting at customs at Dulles Airport, with opportunities to expand to other airports. The ask to nominate unsung champions will also be running on PRX podcast platforms as a 30-second audio ad. America250 has received nominations from Americans across 26 states.

• Partnerships: America 250 worked throughout 2024 to strengthen partnerships with key institutional leaders, including the American Association of State and Local History (AASLH) and the Institute of Museum and Library Services (IMLS). Through these partners, similar organizations, and their member networks, Our American Story aims to tap into a vast network of libraries, historical societies, schools, and community centers and, thanks to the planned digital portal, stand up additional locations across the country where Americans can record their stories.

America Gives

America Gives is America250's signature volunteer, community service, and impact campaign. The program is focused on reinvigorating a national year-round culture of service in the United States through 2026 and beyond. With the ambitious goal of making 2026 a record-breaking year for volunteer service, America Gives will ensure that the Semiquincentennial leaves an enduring, tangible, and positive legacy in communities across America.

In 2024, America250 successfully recruited an extraordinary set of marquee founding partners for America Gives – including iconic American organizations with deep history and well-developed networks of service. Founding Partners include Habitat for Humanity, Blue Star Families, 9/11 Day, Keep America Beautiful, Daughters of the American Revolution, AmeriCorps, and the Peace Corps. Walmart is America Gives' Founding Sponsor. Points of Light has also been onboarded as an America250 National Resource Partner, bringing its unsurpassed expertise and infrastructure as the world's largest organization dedicated to volunteer service. Together, these organizations enable America250 to exponentially increase the reach and impact of America Gives.

America Gives was publicly previewed with a coordinated activation around September 11, 2024—one of the nation's two federally-recognized days of service. As part of the launch, America250 rolled out a new website featuring service opportunities, a two-minute launch video that we shared with the NFL, History Channel, and Corporation for Public Broadcasting to amplify, and featured stories of public service. Chair Rios joined Founding Partner 9/11 Day and 9/11 Families at the New York Stock Exchange to ring the opening bell on the morning of September 11. Following the event, Chair Rios joined 9/11 Day and other America Gives Founding Partners onboard the Intrepid Air & Space Museum to pack meals as part of a day of service. In addition, Representative Robert Aderholt and members of the Congressional America250 Caucus took part in a 9/11 Day meal packing event in Washington, D.C.

The 9/11-oriented preview uncovered insights that have significantly strengthened our planning for 2025 and 2026. Looking forward, we have been able to refine our campaign design, identify more marquee partners for recruitment, and map out the additional infrastructure needs in anticipation of a broader debut of America Gives in summer 2025.

Time Capsule

In 2024, America 250 made notable progress toward meeting the statutory requirement to bury a time capsule in Philadelphia on July 4, 2026, with an emphasis on three major workstreams: location of the capsule, design and build of the capsule itself, and contents.

In 2024, in concert with the National Park Service, America250 worked with Congressional partners on a proposed legislative fix that would broaden the original statutory language dealing with the burial of the time capsule, to allow greater flexibility in its placement and better ensure the long-term survival of the capsule itself.

With that fix on track for approval, America250 engaged over a period of months with the leadership of Independence National Historical Park to identify potential locations for the capsule, with a broad preference for incorporating the capsule into a new planned art installation being planned for the Semiquincentennial.

America250 also worked with partners at the Library of Congress and the National Institute of Standards and Technology (NIST) on the physical design and construction of the capsule. NIST has considered specifications for a vessel that would meet the requirements of preserving materials for 250 years and has offered concepts for three different designs and estimates design and construction will take six to 12 months to complete.

In terms of contents, America250 has sought guidance from the Library of Congress to establish physical criteria for the sort of materials that would be suitable for long-term preservation. In the months ahead, the team will establish broader criteria for substantive content, work with partners across the states and territories to solicit input, and build out a plan for submissions and curation.

America Waves

America Waves is America250's series of nationwide patriotic moments that will bring the country together at a designated local moment of time to pause and reflect on the milestone and create a "Wave of Connection" from Guam to Alaska. Through the America Waves program we will work with partner organizations to deliver hand-held flags to any American household who requests one. The program will also work to organize and amplify community-based events to bring together Americans to wave the flags in unison at 2:50 pm locally on July 4, 2026, and perhaps other moments.

America Waves will partner with national membership organizations *and* local community groups to distribute flags and develop events and activities on July 4, 2026, that pay respect to the meaning behind the flag — unity, freedom, and hope — in ways that are authentic to their community. This strategy offers several opportunities — the chance to expand our reach and create a uniquely accessible, inclusive program; a focus on community impact, including service opportunities, for instance, with veterans' groups that honor and celebrate those who served; and a differentiated approach that distinguish America Waves events from typical July 4 activities by connecting partners at the local and national level, ensuring that participants feel like they are part of something bigger.

The majority of work on America Waves in 2024 was focused on due diligence and initial community partner outreach to assess feasibility and begin planning for the production and distribution of flags to any American who requests one. In 2025, we will make final production and distribution recommendations and decisions so that program implementation, including for community events and other communications activations, can begin in earnest in 2026 in the run-up to July 4.

- Flag Production and Distribution: America Waves has established partnerships with Valley Forge and Annin Flagmakers, America's oldest and largest flagmakers, to help produce/ license collectible American flags for the program. Outreach has also started to engage USPS and other Ex Officio partners, as well as Walmart and others, around flag distribution.
- Community Partnerships and Programming: America250 worked throughout 2024 to strengthen and establish partnerships with key local and national community and membership organizations, including the National Flag Foundation, the Longest Table NYC, the American Horticultural Society, Girl Scouts, cities and towns across the country, and others. Through these partners, similar organizations, and their member networks, America Waves aims to tap into existing communities and social networks as

well as planned July 4 activities. Community partners can leverage their existing relationships to promote America Waves and encourage participation with their followers. By centering our local partners, we can focus on real impact and shine a spotlight on diverse community events, service opportunities, and other opportunities that embody the meaning behind the flag.

Outreach and Engagement

America250's ongoing public engagement efforts have successfully initiated outreach to over 2,000 organizations from faith-based groups, rural America, veterans, Indigenous/Native American (AANHPI), Latino, African-American, and rural communities. Public engagement teams have been engaging local, state, and national organizations to help expand our reach around the rollout of our tentpole initiatives, such as America's Field Trip, Our American Story, and America Gives. As we continue to implement our Playbook, we aim to bring these impactful programs to even more communities across the nation.

We conducted strategic outreach to engage students and families on America's Field Trip. In total, this effort targeted school districts in rural, native and urban communities nationwide, along with dozens of organizations with dedicated civics education programming for students from elementary to college levels. Organizations that were contacted include 4-H, Young America's Foundation, Home School Legal Defense Association, American Council of Trustees and Alumni, National Constitution Center, Hillsdale College, Tunnel to Towers, Focus on the Family, and others.

As we gear up for upcoming rollouts of America's Field Trip, Our American Story, and America Gives, teams have been engaging local, state, and national organizations to help expand our reach. As we continue to implement our Playbook, we aim to bring these impactful programs to even more communities across the nation.

Honorary National Co-Chairs

In August, America250 announced that President George W. Bush, First Lady Mrs. Laura Bush, President Barack Obama, and First Lady Mrs. Michelle Obama will serve as Honorary National Co-Chairs. As Honorary Co-Chairs, President and Mrs. Bush and President and Mrs. Obama will lend their voices to the nationwide effort to mark this historic milestone. The participation of these two Presidents and First Ladies in this initiative, who collectively led the country through the first 16 years of the 21st century, shows a continued dedication to service and commitment to their country.

Partnerships and Partners Update

Throughout 2024, as programs have continued to be rolled out and previewed, America250 has expanded its network of partners and partnerships to support the commission's efforts of reaching 350 million people by the 250th anniversary of the Signing of the Declaration of Independence.

As part of this process, America250 defined its partnerships as follows:

- America250 Advisory Councils: Individuals who are experts in their field and can help amplify America250's efforts and provide guidance on outreach for select program areas.
- **Supporting Partners:** Organizations that help build awareness and support for America250 through a reciprocal branding agreement, and that America250 supports by

- amplifying events and activities on an interactive map and calendar.
- **Programming Partners:** Organizations outside of the federal government that support our programming efforts through in-kind contributions, network support, or by sharing existing programming of theirs to be part of our tentpole programs.
- National Resource Partners: A select group of expert nonpartisan, non-profit organizations that will help elevate and scale America250 programming in exchange for placement in the funding directory.
- **Sponsors:** Organizations providing funding to America250 who receive visibility and awareness for their contributions.

Specifically, in June of 2024, America250 rolled out the National Resource Partner program, a cohort of nonprofit institutions with unique expertise that will help scale America250's effort to become the largest, most inspiring celebration and commemoration in America's history. The cohort of National Resource Partners includes: American Association of State and Local History, iCivics, Meridian International, More Perfect, National Congress of American Indians, Washington National Cathedral, National Women's History Museum, Points of Light, and the United States Conference of Mayors.

Later in the summer, the team secured programming partners in support of America Gives, including AmeriCorps, PeaceCorps, 9/11 Day, Blue Star Families, Daughters of the American Revolution, Habitat for Humanity and the Combined Federal Campaign.

In recent months, America 250 has also signed partners, including YMCA, National Association of Manufacturers, Sons of the American Revolution, Professional Rodeo Cowboy Association, Peoria Riverfront Museum, and more.

Update on Advisory Councils and Cadence

In January 2024, America250 reconstituted the Advisory Councils, bringing twelve councils down to six that more closely aligned with the programs under development. The current Advisory Councils include:

- 1. America's Culture
- 2. Civics, History & America's Future
- 3. American Innovation
- 4. America's Servicemembers
- 5. America's Youth
- 6. America's International Partners

As part of this reconstitution, Advisory Council members are asked to provide guidance on outreach efforts in the lead-up to the 250th Anniversary. America250 Advisory Councils meet four times a year to discuss the programming underway. In addition, America250 team members meet with individual Advisory Councils on an ad hoc basis to discuss specific programming needs.

For example, in November, the Civics, History & America's Future Advisory Council met to discuss ways in which America250 could advance Civics Education as part of the 250th Anniversary. Recommendations from the Councils are taken and discussed among the Commission which gives ultimate direction on a path forward.

New Commissioners

In 2024, five of our six Commission vacancies were filled by Congressional Leadership. Three of the new Commissioners are from the Senate, and two are private citizens. Senate Leader Mitch McConnell appointed Senator Shelley Moore Capito of West Virginia on March 22, and Senator Lisa Murkowski of Alaska on April 19. Senate Leader Charles Schumer appointed Senator Alex Padilla of California on May 8, and Tonio Burgos of New York on November 13. House Speaker Mike Johnson appointed Jimmy Rane of Alabama to the Commission on August 13. See Appendix B.

The Commission now has one vacancy as of January 2025, and we look forward to Senate Leader Schumer appointing a new member that will complete our group of 24 Commissioners, as we approach the Semiquincentennial.

Circulating Collectable Coin Redesign Act of 2020

After years of persistent advocacy led by Chair Rios since 2016, the Circulating Collectable Coin Redesign Act (P.L. 116-330) was finally enacted in December 2020, thanks to the bipartisan efforts led by Congress and signed by President Trump. This legislation paves the way for the U.S. Treasury to issue special quarters emblematic of the 250th anniversary of America's founding. Up to five quarter designs will be issued to honor the contribution of women to critical events in American history. In addition, commemorative \$1 coins will also be minted. The U.S. Mint writes:

"The planned redesign of circulating coinage in 2026 will serve as a tangible reminder of our shared heritage. Adding to the excitement, the Mint even invited the public to participate in a survey about potential design themes, allowing Americans to have a say in how they want to commemorate this momentous occasion. The survey was open from November 3 to December 3, 2023, and asked participants for input about potential themes for the coin designs. Those proposed themes were drafted in collaboration with the United States Mint, the Smithsonian, the National Archives and Records Administration, the National Park Service, and the Library of Congress."

The U.S. Mint plans to release the new coins in 2026. The program will see new designs on many circulating coins, including the Lincoln cent, Jefferson Nickel, and Roosevelt Dime, with special provisions for quarter, half-dollar, and dollar-denominated coinage.

State and Territory Convening

By the end of 2024, America250 realized its long-sought goal of establishing a Semiquincentennial planning Commission in all 50 states, five U.S. territories and the District of Columbia. It was also critical that the milestone of reaching 56 State and Territory Commissions be paired with a commitment to strengthening America250's connectivity and value to each of those Commissions.

Throughout 2024, America250 took concerted action to deepen the federal Commission's relationship with state-level and territory-level Semiquincentennial planning Commissions. A robust cadence of proactive communication with state and territory commissions – as well as more frequent engagement with state and territory commission representatives around tentpole development, execution, and other planning – has yielded significantly improved integration of state and territory efforts into a cohesive national Semiquincentennial framework.

America250's first in-person State & Territory Convening in Washington, D.C., served as the keystone of our improved engagement and information sharing with states and territories. The July 9-11, 2024, convening invited representatives from all state and territory Semiquincentennial planning commissions – as well as observers from the remaining states and territories who have not yet created commissions – for three days of working sessions with representatives from key federal agencies, advisory councils, museum curators, and national partners. Representatives from 46 states and territories attended this convening, making it the most comprehensive gathering of Semiquincentennial planners from across the nation to date.

Presentations included a new landscape and public sentiment analysis from FGS Global, plans from America250 Ex Officio agencies, updates on America250 Tentpole Programs, and featured discussions from museum curators, partner organizations, and experienced state commission leaders themselves. Each state and territory was also invited to present to the plenary session an update on their plans for 2026 – information which has dramatically accelerated our tracking of state-level plans and also enabled cross-pollination of ideas between states that will substantially expedite the work of newer state-level commissions. In breakout sessions, states delved deeper into topics such as working with educators, applying for relevant federal grants, and social media community building, in addition to joining ad hoc regional breakouts to discuss issues of particular relevance to their region. In planning and executing the convening, the partnership of America250's Ex Officio agencies was invaluable in creating efficiencies and delivering an impactful and productive experience to the State and Territory Commission representatives in attendance.

Drawing on the success and learnings of the 2024 State & Territory Convening, America250 is developing plans for a 2025 convening from July 28-30. Our goal is to broaden participation and continue the integration of state/territory and federal Semiquincentennial planning efforts in the critical final year before 2026.

IV. Vision: Where we are headed

America250's focus on the Fresh Start–demonstrating positive momentum, resetting the Commission at the forefront of our planning efforts, and advancing key initiatives such as a new logo, name change, website, and branding–as well as our fiscal due diligence, positions us to scale our work, secure private funds and build a Semiquincentennial worthy of the American people.

Building on the success of America's Invitation, we are launching quarterly public affairs events across the United States to further engage key local leaders and stakeholders. These initiatives aim to augment public involvement in crafting the Playbook for 2026. Simultaneously, we are securing partnerships from public, private, corporate, and non-profit sectors to ensure the programmatic rigor necessary for 2026.

States and territories are actively forming their Commissions, and America250 will convene another grand meeting in 2025 to ensure seamless planning between Federal and State agencies.

As we move into 2025, America250 is working on a number of potential initiatives and partnerships. Note that many of these are in the development stage and may not have been approved by the Commission or prospective partners as of December 31, 2024.

America's Field Trip: Shaping Tomorrow Through the Eyes of Our Youth

We are hard at work finalizing logistics for the field trips that the 75 first-place awardees will take in July and August 2025. As we continue to promote and execute the 2024–2025 contest, we are also exploring how the program can be scaled and enhanced for 2026 and beyond. This includes looking at increasing the number of awardees, and expanding the field trip offerings.

The next few months leading up to the submission deadline for the 2024–2025 contest will be focused on spreading the word about America's Field Trip and encouraging students to enter the contest by April 16, 2025. This will include earned media and digital marketing, targeted constituency outreach, school visits, and potentially a virtual town hall that invites classrooms across the country to learn about America's Field Trip. The next group of first- and second-place awardees will be announced in late May or early June 2025.

We will be soliciting field trip proposals for 2026 contest awardees from a variety of stakeholders in the spring of 2025 with the goal of finalizing the destinations over the summer before the contest kicks off for the 2025–2026 school year in September.

Our American Story

Upon its launch on July 4, 2025, Our American Story will comprise four major component efforts:

• "Main Street" will represent the most sweeping component of Our American Story and the primary effort to gather stories from everyday Americans in the year leading up to the Semiquincentennial. A showcase piece of the Main Street story-gathering will come through a partnership with StoryCorps, centered on a 10-stop road trip using existing StoryCorps equipment and visiting all the regions in the contiguous 48 states. 2025 stops will bring the tour to the Midwest, the Mountain West, the Southwest, and the West

Coast. Audio of stories gathered as part of the road trip will be preserved indefinitely by the Library of Congress.

- Institutional and Organizational Partnerships will further enhance Our American Story's ability to reach as many Americans as possible. Beyond the previously mentioned discussions with AASLH, IMLS, and other partners, America250 has also prioritized outreach to membership-based organizations focused on community service and volunteerism. These organizations and their built-in membership networks can help drive a truly grassroots movement to participate in Our American Story. To date, the Girl Scouts has expressed interest in this model, and other organizations could potentially include DAR, AARP, Urban League, VFW & American Legion, Kiwanis, Rotary and Lions Clubs International, youth sports, NCAI, LULAC, USO, Honor Flights, and more.
- American Icons and Key Leaders is a planned partnership series that would feature prominent Americans from diverse fields and backgrounds who have made significant contributions to our country. The interviewees could include current and former presidents and other officials, authors, industry leaders, and interesting "influencers" with a bent towards both our history and our future through a non-partisan lens.
 - Beginning in July 2025 and culminating in July 2026, America 250 envisions hosting a monthly interview series, potentially in partnership with different presidential libraries to add localized branding, help drive audience, and provide additional structure to the series.
- "The Story of Our American Story" will document this project as it unfolds in the run-up to the Semiquincentennial in an effort to amplify the gathered stories and bring them to life for a broader audience. The purpose of this effort would be to amplify the impact of Our American Story, elevate particular stories gathered as a way to inform and inspire viewers about the triumphs and challenges that have shaped our nation, and create a lasting legacy for Our American Story and a valuable educational resource.

 America250 envisions working in partnership with a media organization or streaming platform to help plan and implement this component of the project.

With the proposal outlined above, along with the appropriate resources, Our American Story is well-positioned to push ahead in earnest and add to the growing success of America250 programming.

America Gives

America250 plans to launch America Gives in full in 2025, raising a nationwide call to action to organizations of all kinds to plan more ambitious goals for volunteer service and leave a lasting impact in the Semiquincentennial year 2026. America Gives will seek to unite volunteer organizations, membership groups, corporate America, youth groups and schools, and faith-based service networks in common purpose to make calendar year 2026 a record-setting year of volunteer service in America. Our ambition is to reignite a culture of service and impact far beyond 2026, and leave an indelible, positive effect on communities across America that are supported by the volunteerism of ordinary citizens working in concert.

During the first and second quarters of calendar year 2025, America250 plans to develop the key program infrastructure needed to record, verify, and aggregate hours of service at a national scale. In parallel, we will work to recruit additional priority partners and engage service networks in

preparation for a tentative summer 2025 full launch of the campaign. For the remainder of 2025, America250 will work to extend our call to action and further widen our circle of participating organizations to make plans for service in 2026.

Across the Semiquincentennial year, America Gives will generate and elevate stories of service drawn from trusted partner organizations – sustaining a steady drumbeat of visibility that helps build momentum for volunteerism in communities across America.

Other Tentpole Programs that were mentioned earlier, America Innovates, America's Culture, and July 4 activations are in development and will require extensive planning and engagement with all of our stakeholders.

Ambassadors/Talent/Influencers

In June 2024, we launched the America250 Ambassador Circle alongside notable individuals from regions around the country who volunteered to lend their voices and their platforms to raise awareness of America250. As part of the initial cohort of Ambassadors, we were pleased to announce the following individuals:

As we continue building upon our programs, the goal is to help build a roster of influential supporters for A250, and as we build stronger relationships with talent, we will determine the best ways to leverage our Ambassador Circle as spokespeople for specific A250 programs, campaigns, and projects. Talent can be particularly helpful for opportunities where the barrier to entry is a high-profile supporter; we'll ensure the use of talent in A250's initiatives which will help ensure mainstream visibility for the various programs.

Our Ambassador Circle will work to advance the organization's mission and engage with more Americans. Ambassadors can speak on behalf of the organization at events in each of their states, participate in media engagements, amplify America250 efforts on social media, and participate in the specific programs we've outlined below. In addition, these individuals will provide guidance and strategic input about future America250 programming and initiatives in their local communities and across the nation. Specific responsibilities will include the following:

- Represent America 250 in key events and communications, including:
 - Participation in media interviews (broadcast, online, print, podcasts);
 - Amplifying America250 news, events, campaigns, or general messaging through social media or other platforms;
 - o Inclusion of name, photo, and bio on the America 250 website and on social

- media;
- Capture a video as part of America's Invitation to share talent's story about what America means to them.
- Advise or assist with the identification and engagement of potential individuals (ie. teammates, castmates, etc.), corporate (ie. brand marketing teams), foundation partners, and prospective donors (i.e. talent-led foundations), including making introductions where appropriate.
- Meet with America250 representatives on an as-needed basis to advise on strategy to engage key constituencies.

Additionally, we'd like to implement a Champions role to attract the highest tier of talent - in parallel with the Ambassador Circle, Champions will still represent America250 and raise awareness around the celebrations, but in a lighter lift capacity given their demanding and unpredictable schedules.

The Champions will also represent the A250 organization and work to bring its mission to the forefront for many Americans. As these talent supporters will be of a higher caliber, we'd present the following lighter-lift responsibilities to their teams to ensure this role works with their busy and unpredictable schedules:

- Represent America 250 in key events and communications, including:
 - Amplifying America250 news, events, campaigns, or general messaging through social media
 - Inclusion of name, photo, and bio on the America250 website and on social media;
 - Capture a video as part of America's Invitation to share talent's story about what America means to them

Development Update

America 250 deeply appreciates the continued support of Congress through annual appropriations, which remain a critical foundation for our mission. However, private investment is essential to executing the largest and most inspiring celebration and commemoration in American history.

Over the past several years, America250 has prioritized building strategic relationships with major gift supporters, corporate partners, and philanthropic institutions. Chair Rios, alongside key Commissioners, has been actively engaging leaders across industries to secure both financial contributions and in-kind support critical to our success.

These efforts are already yielding significant results. At the end of 2024, we secured \$15 million from our largest sponsor to date, along with additional commitments from a growing network of partners. With these investments and the continued momentum behind our National Tentpole Programs, America250 is well-positioned to scale its impact in 2025 and beyond. We remain committed to leveraging both public and private resources to educate, engage, and unite all Americans in the lead-up to our nation's Semiquincentennial.

We look forward to continued collaboration with Congress and our partners to ensure that America 250 serves as a unifying and impactful commemoration and celebration, engaging Americans in honoring our past, celebrating our present, and shaping our future.

V. What we need from Congress

America250 is excited to move into the next phase of its operations with programming and events that will capture the attention - and the spirit - of the American people, as directed by the U.S. Semiquincentennial Act. None of these plans would be possible without the continued commitment by Congress to provide sufficient funding to support the Commission's ability to fulfill this mission in an extraordinary fashion.

America250 is deeply grateful for Congress' support of the Commission, both through the work of the appointed members of Congress who serve as Commissioners and the funding support the Commission has received annually beginning in FY 2019.

At all times, America250 seeks to be a good steward of the public trust bestowed on the Commission and its Commissioners and to be aggressive and prudent in its responsibilities for managing the Federal funding appropriated to it.

As we approach 2026, America250 will need Congress's ongoing commitment to help create the enthusiasm and momentum required across all corners of our nation to execute a 250th anniversary worthy of the American people. With two more fiscal years left, we are scaling our latest appropriations request to \$100 million to align with our ambitious programming. The majority of the Commission's expenses since Chair Rios' tenure have been focused on engaging the American public, and based on the success of America's Invitation and the 250th anniversary of the Boston Tea Party, it was funding well-spent. To date, we have experienced increases in active participation of our State and Territory Commissions, corporate and community partners, Congressional America250 Caucus members, and most importantly, Main Street America demonstrating that we have engendered the trust that has alluded the Commission in the past. The additional Tentpole Programs that we are proposing are high-impact, large-scale, galvanizing, purpose-driven and meaningful programs that will significantly impact the American public, and especially the next generation of leadership. And if we are effective, many of these programs can even sustain themselves long after 2026 through our partnerships.

Moving forward, in addition to the funding support that we will need to execute this once-in-a-lifetime experience, members of Congress can assist by joining the Congressional America250 Caucus. Finally, the Commission hopes to call on members of Congress to attend and support upcoming events at the Federal, State, and local levels to share the message and mission of America250 with their constituents.

VI. Working with the White House

America250 has set the table, and built a **movement** that is galvanizing people and communities across the country. Now, we are thrilled to collaborate with the White House to inspire the **big moments** that ensure this is the most significant celebration in our nation's history.

The recent Executive Order, "Celebrating America's 250th Birthday," underscores the Administration's commitment to a coordinated planning process, formally recognizing the U.S. Semiquincentennial Commission as a key partner in this national effort. Through the establishment of the White House Task Force 250, the Administration provides an important framework for collaboration and will allow America250 to align with federal partners and drive a nationwide commemoration worthy of the American people.

We are deeply grateful for the opportunity to work alongside the transition team, the Cabinet, federal agencies, and Congress. Looking ahead, we are excited about expanding the America250 team by welcoming new ambassadors, advisory council members, and other key collaborators. These individuals will play an integral role in broadening the reach and impact of our mission.

We are also keen to partner with the White House to enhance our current activations, introduce new initiatives, and solidify the programming for July 4, 2026. Together, we can channel our collective enthusiasm and momentum to ignite a nationwide movement. Current activations such America's Field Trip, America Gives, and Our American Story are already fostering engagement across the country, laying the groundwork for this once-in-a-generation celebration.

Appendix A – Legislative History

The U.S. Semiquincentennial Commission Act was introduced in the House of Representatives by former Representative Pat Meehan from Pennsylvania and referred to the House Committee on Oversight and Government Reform. It was considered and approved on the House Floor under suspension of the Rules on July 5, 2016, and subsequently approved by unanimous consent on July 12, 2016. Because of the need for some technical changes (adding Ex Officio members, recognizing the Commission's logo, and the desire for Federal funding), the U.S. Semiquincentennial Commission Amendments Act was introduced in the Senate by former Senator Pat Toomey of Pennsylvania and referred to the Senate Judiciary Committee. It was approved by the Committee and was passed by the Senate on July 21, 2020. Subsequently, the House approved the bill with some amendments with the approval by the Senate, and the bill was sent to President Donald Trump. It was signed into Public Law on December 31, 2022 (P.L. 116-282 (134 Stat. 3386)).

Appendix E - 2023 Federal, State and Legislative Engagement

a. Federal and International Partnerships

The Federal team plays a vital role in unifying the diverse components of the Federal government, encompassing executive agencies, independent agencies, commissions, boards, committees, and other relevant entities. Their primary objective is to facilitate the collective participation of these entities in commemorating the significant milestone of the 250th anniversary of the founding of the United States. By fostering collaboration and coordination across these various corners of the Federal government, the team ensures a cohesive and inclusive approach to honoring this momentous occasion in the nation's history.

In addition to working closely with the 12 agencies specified in the U.S. Semiquincentennial Commission Act, the Federal team has been actively engaged with approximately 20 additional agencies. We are also diligently pursuing strong connections with all Federal agencies to encourage and support participation in the Semiquincentennial commemoration. In addition to our Ex Officios, agencies that have been engaged in 2024 include Americorps, U.S. Department of Agriculture, Veterans Affairs, NASA, the National Gallery of Art, the U.S. Postal Service, Government Publishing Office, U.S. Mint, and Census Bureau. The involvement of Federal agencies is paramount to the development of our commemoration planning process.

To ensure effective collaboration across all of America250's Federal partners, four primary communication channels have been established:

- Meetings with Agency Ex Officio Representatives: These meetings serve as a platform for thoughtful and engaging conversations about activities related to the America250 commemoration. The Agencies' participation in these meetings has been consistent, and they have provided valuable feedback to enhance the planning process.
- **Bi-Monthly Working Groups:** America250 works with federal agencies to convene three working groups: 1) National Mall and Visitor Experience, 2) Civics and Education, and 3) Marketing and Feedback. These meetings serve as an opportunity for Ex Officio partners to convene and discuss the core 2026 programming tentpoles, align on key activation dates, and coordinate associated planning efforts. Ex Officio members diligently attend these meetings and provide topics for discussion in advance to ensure we cover the latest updates and due-outs.
- Quarterly Meetings with Communication Directors and public engagement officers: These interactions have facilitated effective communication strategies, ensuring information is appropriately shared with the public and key stakeholders.
- Legislative Brainstorming Meetings: Consisting of a broad group including five Congressional offices and various Federal agencies/commissioners.

b. State Commission Activity

America250 seeks to ensure that each and every American has the opportunity to engage with and participate in the commemoration and celebration of our nation's 250th anniversary, and most Americans will have the opportunity to do so at the local and State levels. Therefore, America250 worked to encourage all U.S. States, five territories, and the District of Columbia to establish their own Semiquincentennial planning entities through legislation or executive action for the anniversary. All 56 Semiquincentennial planning entities have been created and America250 continues to coordinate and collaborate with all through regular communication and targeted outreach. This is an additional 13 that were brought on during 2024. See Appendix F for the list of names and creation dates of State and Territory Semiquincentennial planning entities.

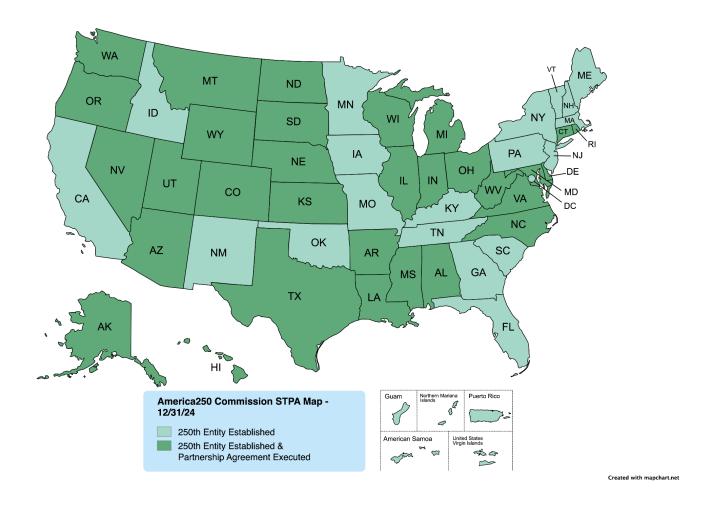
State Collaboration Efforts: During 2024, America250 provided significant, ongoing planning support and counsel to State and Territory Commissions, via virtual briefings, one-on-one meetings, and the 2024 State & Territory Convening. This support included and/or resulted in:

- Significant participation by State and Territory Commissions in amplifying America's Field Trip to their networks of schools, educators, youth groups and media contacts.
- Partnership around key historical moments, notably the 250th anniversary of the First Continental Congress in Philadelphia.
- Chair Rios and senior leadership of America250 addressing state commission meetings and engagements including Alaska, Arkansas, Texas, Virginia, and Washington.

Partnership Agreements: As of December 31, 2024, 31 states have executed the America250 State and Territory Partnership Agreement (STPA). Each State has been provided a trademarked America250 logo, the option to use a secured domain name for its website, and the option to receive \$10,000 in funds to support Semiquincentennial planning initiatives.

The following 31 States have executed the STPA: Alabama, Alaska, Arizona, Arkansas, Colorado, Connecticut, Delaware, Hawaii, Illinois, Indiana, Kansas, Louisiana, Maryland, Michigan, Mississippi, Montana, Nebraska, Nevada, North Carolina, North Dakota, Ohio, Oregon, Rhode Island, South Dakota, Texas, Utah, Virginia, Washington, West Virginia, Wisconsin, and Wyoming.

Several additional Semiquincentennial planning entities are considering executing the STPA to support their planning efforts.

The Commission has one vacancy: a private citizen to be appointed by Senate Leader Charles Schumer. See Appendix B.

• Congressional America250 Caucus and Activity: As America's Semiquincentennial approaches, America250 is on a mission to encourage all 541 members of Congress to join the Congressional America250 Caucus. Members of the Caucus are kept informed of activities and preparations related to America250 and upcoming commemorations of the 250th anniversary of the signing of the Declaration of Independence. As 2026 nears, Caucus members will be encouraged to get involved in briefings, meetings, and promoting America250 on the national stage, in their state, and in their communities whenever possible.

The Caucus co-chairs are the elected members of the Commission, including Senators Shelley Moore Capito (R-WV), Lisa Murkowski (R-AK), Alex Padilla (D-CA), and Jeanne Shaheen (D-NH), and Representatives Robert Aderholt (R-AL-04), Dwight Evans (D-NJ-03), Maria Elvira Salazar (R-Fl-27), and Bonnie Watson Coleman (D-NJ-12).

America 250 continues to contact Congressional Members and staff regarding invitations to join the Congressional America 250 Caucus.

As of December 31, 2024, the Congressional America250 Caucus had 260 Members, including 40 U.S. Senators and 220 Members of the U.S. House of Representatives, an increase of 146 Members since the end of 2023. As States and Territories announce the creation of State Commissions, America250 works to inform Members of the State's congressional delegation. Letters are sent providing an update on the creation of the State Commission and inviting Members to join the Caucus. See Appendix G.

In-person Congressional America250 Caucus receptions were held on January 17, June 5, and September 18, 2024, on Capitol Hill. Hosted by the Commission, Chair Rosie Rios greeted fellow Commissioners, Caucus members and other Members, and numerous Congressional staff, representatives of Federal Ex Officio agencies, and several interested parties. At the receptions, the primary topics of discussion were the scheduled launch of America's Field Trip, the Commission-approved programs, and continued collaboration with all States and Territories in development of their planning efforts.

A Congressional America250 Caucus reception was also held on December 10, 2024. Chair Rios and Commissioner Aderholt spoke to the group about ongoing America's Field Trip program, the growing involvement of our Ex Officio Federal partners, achieving the goal of 250 Caucus members, and achieving the goal by governors in creating Semiquincentennial planning entities in the 50 states, the five Territories, and the District of Columbia.

Monthly reports on America250's actions and activities are being distributed by the office of Representative Bonnie Watson Coleman to all Congressional America250 Caucus members.

• Semiquincentennial Time Capsule Act: On November 14, 2023, Representative and Commissioner Bonnie Watson Coleman of New Jersey, introduced the Semiquincentennial Congressional Time Capsule Act (H.R. 6394). The bipartisan and bicameral bill, part of the

nation's planned Semiquincentennial celebration, would authorize the Architect of the Capitol to create a time capsule and have it buried on the west lawn of the Capitol, to remain sealed until July 4, 2276, the nation's 500th Anniversary. The contents of the time capsule will be determined by the offices of the Speaker of the House, the Office of the Minority Leader of the House, and the Offices of the Majority and Minority Leaders of the Senate. They will include items that represent important legislation or institutional milestones of Congress, a message from the Congress to the future Congress, and other items that reflect our history at the time. Also on November 14, 2023, a companion bill (S. 3293) was introduced by Senator and Commissioner Jeanne Shaheen of New Hampshire. H.R 6394 was approved by the House on December 16, 2024. Although the bill was sent to the Senate for consideration, they did not move on it. A new bill is expected to be introduced in 2025.

• Special Session at Independence Hall

In honor of the Semiquincentennial of the signing of the Declaration of Independence, on June 25th, Representative Brendan Boyle (D-PA-02) of Pennsylvania introduced House Concurrent Resolution 115 calling for Congress to hold a joint session of Congress at Independence Hall, in Philadelphia, on Thursday, July 2, 2026. The Resolution had been referred to the House Committee on the Judiciary but went no further. A new Resolution is expected to be introduced in 2025.

- Reports to the President and the Congress: Pursuant to Public Law 114-196, Section 9(d), the Commission is required annually through December 31, 2027, to "submit to Congress a report of the activities of the Commission." An annual report for 2023 to the President and Congress was submitted on January 23, 2024. The report reflects action and activities and provides a general overview describing the path forward for America250. The report was provided to Commissioners and members of the Congressional America250 Caucus. The report is available on the America250.org website.
- Quarterly Reports: Included in underlying legislation of H.R. 133 of the Consolidated Appropriations Act, 2021, enacted on December 27, 2022, is language directing the Commission to provide the Appropriations Committees with quarterly reports detailing spending by activity to continue to help the Committees understand the Commission's funding needs. The Commission continues to provide the Committees with quarterly reports.
- **FY 2024 Budget Request**: The Commission approved its budget request of \$30,000,000 for FY 2024. The Commission's \$30,000,000 request was included in President Biden's budget request to Congress, released on March 9, 2023. The Commission coordinated with its elected Commissioners for submission to the Appropriations Committees.

During the 1st quarter of FY 2024, Congress passed two Continuing Resolution (CR) to continue government operations into FY 2024. The CR (P.L. 118-15) continued through November 17, 2023. The second CR (P.L. 118-22) continued government operations through February 2, 2024, for the Department of Interior and several other departments. A third CR (P.L. 118-40) continued

operations through March 8, 2024.

Congress approved an appropriations bill that included funds for Interior Appropriations and \$15,000,000 for the U.S. Semiquincentennial Commission. Public Law 118-42 was enacted on March 9, 2024.

• **FY 2025 Budget Request**: The Commission approved its budget request of \$100,000,000 for FY 2025. The Commission's \$100,000,000 request was included in President Biden's budget request to Congress, released on March 11, 2024. The Commission coordinated with its elected Commissioners for submission to the Appropriations Committees.

For continuing government operations into FY 2025, Congress passed two Continuing Resolutions (CR). The first CR (P.L. 118-83) continued through December 20, 2024. The second CR (P.L. 118-158) continues government operations through March 14, 2025. Action on the FY 2025 appropriations bills is expected in 2025.

• **FY 2026 Budget Request**: The Commission is preparing its budget request for FY 2026, a fiscal year that will include the actual anniversary of the signing of the Declaration of Independence - July 4, 2026. The budget request will reflect the funding required to implement the national programs and activities approved for execution by the U.S. Semiquincentennial Commission.
